
Dear Colleagues


ACS is responsible for the hospitalization of millions of patients every year and, as such, the burden placed on global healthcare systems by the associated morbidity and mortality is considerable. Currently available therapies recommended by published guidelines could potentially have a number of limitations. New and emerging anticoagulants that target specific steps in the coagulation cascade are being developed, in particular with the aim of improving the benefit:risk ratio.

During this symposium, Dr Harald Darius will introduce ACS and discuss current and historical anticoagulation treatment practices and their established benefits. He will also present evidence demonstrating the benefit of long-term anticoagulation plus antiplatelet therapy in managing ACS. Dr Shamir Mehta will move the discussion on to new and emerging treatments, highlighting the rationale for inhibition of factor Xa as a specific mechanism in the management of ACS. Finally, Dr Harrington will introduce the benefits of direct factor Xa inhibition and review the ongoing clinical development programs for novel, oral, direct factor Xa inhibitors in the secondary prevention of cardiovascular and cerebrovascular events in patients with recent ACS.

There will be opportunity for interactive discussion at the end of the session and we anticipate some lively debate between the panel and our colleagues. We look forward to seeing you in Munich.
