GENERAL CONDITIONS

Registrations will be acknowledged by email upon receipt of payment and personal address on your individual registration form (we kindly remind you that sponsor addresses are not accepted).

Registration fees are based on the date of receipt of the registration form and payment. The prices indicated are only applicable if BOTH the registration form AND the payment are received before the deadlines, otherwise the higher registration fee will be applied. The deadline for pre-registration is 31 July 2008. After this date, you will need to register on-site in Munich. The registration desk will be open from 10:00 on Friday, 29 August 2008.
