GENERAL CONDITIONS

The ESC has reserved rooms in Lyon in various price category hotels.

Upon receipt of the deposit payment, a voucher will be sent to the participants by e-mail or mail. This voucher must be presented to the hotel and upon departure the deposit payment will be deducted from the total bill.

PAYMENTS

By credit card:

Deposit for two nights accommodation (according to requested hotel and room type). In case of late cancellations or no-shows, the ESC reserves the right to debit credit cards for any additional nights originally booked if required by the hotel.

By bank transfer:
