I serve as the Director of the cardiovascular clinics, and Head of the Heart Failure service at Tel Aviv Sourasky Medical Center. Additionally, I hold the position of Secretary of the Cardiomyopathy Section within the Israel Cardiology Association.

My contributions to the HF community include:

- Promoting HF Over the past 5 years, I have spearheaded the number of our facility's HF clinics from 2 to 11 per week, facilitating a total of 2800 visits annually, marking a remarkable 180% increase.
- 2. Advanced HF care as the Head of the HF daycare unit, we provide unique repetitive intermittent IV inotropes therapies including Milrinone and Levosimendan, as detailed in a recent publication in Clin Cardiol (2022;45(5):488-94).
- 3. Remote GDMT up-titration collaborating with the Israel Ministry of Health, I have contributed to the development of a smartphone application designed to supervise the uptitration of GDMT, integrating patients' vital signs, steps, blood tests, quality of life questionnaires, to optimize GDMT.
- 4. Academic engagement As a senior lecturer at the Tel Aviv Faculty of Medicine and applied for clinical associate Professor, I'm actively involved in mentoring doctoral students, guiding interns, and delivering lectures at numerous HF conferences. Additionally, I organize biannual conferences on cardiomyopathies and HF as part of my role in the Israel Cardiology Association. Moreover, I have a Master of Health Administration (MHA) degree from the Guilford Glazer School of Business and Management, and I serve as an ad hoc reviewer for several journals (JACC CardioOncology, ESC HF, Canadian Journal of Cardiology), while also holding editorial positions in Cardio-Oncology journal and the European Journal of Medical Research.
- 5. PI role I serve as a PI in several HF clinical trials including ALLAY-HF, CORDIO, and RELIEVE-HF trial, on which I'm an author in the main results paper soon to be published. Moreover, I served as the PI in the ESC HFIII registry.

- 6. Research I have published 54 original papers, with 29 as a leading author, and presented 35 abstracts at international conferences, including the ESC, ESC HFA, ACC, and AHA. I'm actively engaegd in a number of International collaberation, including the ICI-Myocarditis registry led by Prof. Javid Moslehi (JAMA Cardiol. 2021;6(11):1329-37), development of an AI model for CV risk iassessment in cancer patients in partnership with the University of Illinois (Eur Heart J Digit Health. 2023 May 8;4(4):302-31), and with both the RELIEVE-HF and ALLAY-HF teams, with pending publications. Additionally, I have received research grants from several pharma companies, totaling ~230 000 USD over 2019-2022.
- 7. Innovative programs I initiated the cardio-oncology clinic in 2016, now the largest in Israel, complemented by a prospective registry (ICOR) and an innovative cancer rehabilitation program in 2022, offering comprehensive support to cancer survivors through multidisciplinary interventions, and supported by the Israel Cancer Association.
