

# RULES & REGULATIONS EHRA Congress Educational Grants 2024

### **GRANT BENEFITS**

- A standard congress registration to EHRA 2024 Congress, onsite participation in Berlin, Germany.
- Grant recipient will be automatically registered
- Accommodation and travel is not covered

#### **RULES**

- The grant is intended for the EHRA 2024 congress only
- In case of absence due to illness, force majeure or other unavoidable circumstance, the grant award would be deemed lost and the candidate is asked to justify his/her absence
- The grant applicant certifies to work in an ESC member country or ESC Affiliated Country
- The grant recipient must be an <u>EHRA member</u> at the time of his/her application and at the time of the congress.
- Applicants in training as well as 2023 grant winners are not eligible for this year's grant.
- All paperwork (visa, study leave, etc...) remains the grant recipient responsibility
- The grant recipient is eligible for one source of funding only. If alternative funds are available on top of this grant for EHRA 2024 Congress, the <a href="EHRA Selection Committee">EHRA Selection Committee</a> must be informed immediately so that the grant, or part of the grant, is reallocated to someone else

## **PROOF OF ATTENDANCE**

- Within the scope of this grant, presence at the EHRA 2024 Congress in Berlin is mandatory.
- The grant recipient must attend the entire congress (Sunday 7- Tuesday 9 April 2024)

# **GRANT PAYMENT**

- The EHRA educational grants consist of a free onsite registration in Berlin, Germany.
- Travel and accommodation are not covered. Grant recipients are responsible for their own travel and accommodation

### **PERSONAL DATA PRIVACY**

The information collected for EHRA Congress Educational Grants is subject to data processing to evaluate and approve/reject the application. If the application is approved, the data will further be used to process the grant.

Without this information, we will not be able to consider your application for a grant.

The recipients of the data are ESC Staff for processing and the Independent Selection committee receives a link to your application for the selection review process.

Data collected will be kept for a maximum of 5 years after your last transaction or activity with us, after which time your My ESC account will be closed. A record of financial transactions will be kept for a period of 10 years for legal accounting purposes.

The ESC supplies this information to its CRM service providers (eg Salesforce) for account management and to the Bank partner for the transfer of the Grant amount.

In accordance with the chapter 3 of the European Regulation 2016/679 with regards to data protection, you have the right to request from ESC, access to and rectification or erasure of your personal data or restriction of processing concerning your data or to object to processing as well as the right to data portability.
