



## **RULES & REGULATIONS**

### **EHRA Congress Educational Grants 2022**

#### **GRANT BENEFITS**

- €500 (Five hundred Euros), a contribution towards costs of travel and accommodation\* to attend EHRA 2022 congress
- A standard congress registration to EHRA 2022 Congress. Grant recipient will be automatically registered (registration confirmation and voucher will be sent by email).

*\*Travel and accommodation arrangements are the grant recipient's responsibility*

#### **RULES**

- The grant is intended for the [EHRA 2022 congress](#) only
- In case of absence due to illness, force majeure or other unavoidable circumstance, the grant award would be deemed lost and the candidate is asked to justify his/her absence
- The grant applicant certifies to work in an [ESC member country](#) or [ESC Affiliated Country](#)
- The grant recipient must be an [EHRA member](#) at the time of his/her application
- All paperwork (visa, study leave, etc...) remains the grant recipient responsibility
- The grant recipient is eligible for one source of funding only. If alternative funds are available on top of this grant for EHRA 2022 Congress, the [EHRA Selection Committee](#) must be informed immediately so that the grant, or part of the grant, is reallocated to someone else

#### **PROOF OF ATTENDANCE**

- Within the scope of this grant, presence at the EHRA 2022 Congress in Copenhagen is mandatory. The grant recipient must attend the entire congress (Sunday 3- Tuesday 5 April 2022)
- The payment of this grant is conditioned by the attendance, being recorded onsite, it is mandatory to sign in and out at the EHRA 2022 Congress Grants dedicated desk onsite, with a national identity card/passport:
  - the first day upon arrival, 3 April
  - and the last day upon departure, 5 April

#### **GRANT PAYMENT**

- Personal bank details must be completed on the secure My ESC platform
- To ensure a smooth operation, all your contact details must be updated
- A bank transfer will be made after EHRA 2022 Congress, if attendance is validated

## **PERSONAL DATA PRIVACY**

The information collected for EHRA Congress Educational Grants is subject to data processing to evaluate and approve/reject the application. If the application is approved, the data will further be used to process the grant.

Without this information, we will not be able to consider your application for a grant.

The recipients of the data are ESC Staff for processing and the Independent Selection committee receives a link to your application for the selection review process.

Data collected will be kept for a maximum of 5 years after your last transaction or activity with us, after which time your My ESC account will be closed. A record of financial transactions will be kept for a period of 10 years for legal accounting purposes.

The ESC supplies this information to its CRM service providers (eg Salesforce) for account management and to the Bank partner for the transfer of the Grant amount.

In accordance with the chapter 3 of the European Regulation 2016/679 with regards to data protection, you have the right to request from ESC, access to and rectification or erasure of your personal data or restriction of processing concerning your data or to object to processing as well as the right to data portability.
