Short CV

Dr. Mirza Dilic received his undergraduate medical degree and specialty Internal medicine training in Sarajevo, Bosnia & Herzegovina (B&H) and Zagreb, Croatia as well as Cardiovascular training in Edinburgh, Scotland, UK. Then, he was appointed at University Clinical Center Sarajevo, as Senior Lecturer/Consultant in Vascular Diseases and he established and developed Vascular Diseases (ASCVD) services for B&H, as one of the centers of excellence in the B&H. He was subsequently promoted to Full Professor at the Sarajevo University School of Medicine. He has been involved in EORP studies, EUROASPIE IV and EUROSPIRE V as National Coordinator and Principal Investigator as well as in ISACS-CT Trial. As Chair for Vascular Diseases services he introduced, for the first time, techniques of Color Doppler examination in B&H and organized International School of Color Doppler. He was one of the founders of B&H Association of Cardiologists and Angiologists (1996 -) and appointed as ESC National Coordinator for CVD Prevention (1998 -). Dr Dilic introduced, for the first time in FB&H SCORE Risk Chart assessment. He was also Editor-in-Chief of Cantonal Clinical Guidelines Edition (29 Guidelines) and Guidelines for Patients (5 Guidelines).

Dr. Dilic has been actively involved in studies on ASCVD and published extensively on the topic, resulting in over 90 articles published in peer-reviewed journals, 8 book chapters and 2 University Textbooks. He was the first that introduced a new anti-platelet Tx. as well as NOACs Tx. in the country. He has given over 90 invited lectures at international congresses, meetings, courses, and symposia. He is actively involved in postgraduate and doctoral teaching as director of Ph.D. studies at the Sarajevo School of Medicine. Finally, Dr Dilic served as Board Member (1996 -) of B&H Association of Cardiologists and has been granted as Fellow of ESC (2007 -) and Fellow of ACC (2010 -).
