What would you like to achieve if you were elected? Please provide your 3 main topics (max 500 words)

I wish to stand for the position of Treasurer of the EAPCI as I am committed to the work of the EAPCI and I believe this role provides a valuable opportunity to actively contribute to the following:

Sustainability of EAPCI

The last 2 years have been particularly challenging throughout the pandemic with economic difficulties requiring scrutiny of all expenditure. Alongside the Board, I would like to ensure the ongoing sustainability of the EAPCI, as a world leading association in the field of PCI. Collaborative opportunities need to be captured with engagement and communication with all partners and stakeholders. The membership of EAPCI could be amplified by demonstrating the benefits and increasing the visibility of the association. This will require innovation and continued well managed resources targeted at the priorities of EAPCI.

Education and Training

I would also like to maintain the high standards in education and training for those individuals wishing to pursue a career in interventional cardiology and ensure equality of access to this. The EAPCI have made huge progress in this area, including the core curriculum, European certification of professional excellence (not only for physicians but also for nurses and allied professionals) and the allocation of training grants for young interventional cardiologists. The endorsement of these opportunities, plus the development of a successful mentorship scheme for fellows in training and access to role models to provide career guidance and advice

would support individuals in their growth as interventional cardiologists. Continued access to quality educational webinars and events should be available to all for the benefit of maintained professional excellence and networking for all members of the EAPCI. The methods of this have changed throughout the pandemic, but should be innovative and inclusive.

Quality Research

There does remain disparity in patient outcomes within interventional cardiology and the COVID-19 pandemic has potentially led to increasing inequality in the access to investigation and treatment of cardiovascular disease. The attainment of quality collaborative research between the EAPCI and other ESC associations is therefore essential to contribute to the awareness and resolution of this. I would therefore wish to support scientific and clinically relevant studies and promote with the EAPCI.

If you were elected, how do you envisage to organize yourself to accommodate this very time demanding additional commitment?

Throughout my consultant career, I have had a number of varied roles, including clinical, educational, leadership and academic, which have each required time investment. At times these may have been conflicting, however I have demonstrated throughout that I am able to maintain strict time management to allow completion effectively. I recognize fully the importance of this role as Treasurer of EAPCI, which would be prioritized alongside my other roles. I have the strong support of my colleagues and team to enable me to commit to this and be successful.
