#### Objective 1: Strategic Financial Planning for EAPCI Education and Research

The primary goal is to ensure EAPCI's financial stability and growth, while investing in the education and professional development of interventional cardiologists.

## Strategies:

- To prioritize the allocation of funds towards educational programs (fellowship & training grants, educational and training webinars) ensuring international exchange and access to achieving recommended competency and skills in interventional cardiology.
- To collaborate with EAPCI's President and board to identify and support international studies
  that can provide invaluable insights into the practices and outcomes of interventions, guiding
  both clinical practice and policy.

#### Objective 2: Drive Effective Fundraising and Resource Allocation

EAPCI should effectively mobilize resources through fundraising and resource allocation. The actions should allow open access to EAPCI membership and provide international EAPCI research grants.

# Strategies:

- o To lead and **innovate in fundraising activities**, identifying new opportunities for partnership and sponsorship that align with EAPCI mission.
- o To direct resources to **minimise EAPCI membership fee** and allow wide geographical and cultural representation of Interventional Cardiology operators .
- o To plan educational and research projects and initiatives, prioritizing those that offer significant benefits to our members and advance patient care.
- To allow to fund prespecified EAPCI Committee meetings

# Objective 3: Boost Transparency, Compliance, and Engagement in Fundraising

A transparent operation and adherence to regulations are pivotal for earning member trust and facilitating successful fundraising efforts.

#### Strategies:

- To conduct transparent reporting and compliance practices bolstering confidence among potential donors and partners in our governance.
- To engage and inform EAPCI community on the fundraising endeavors, highlighting existing needs among EAPCI member countries.
- To conduct survey on EAPCI member country needs for effective fund use addressing current barriers to Interventional Cardiology research and education.
