Currently, an Academic Scholar (Adjunct Lecturer) at the 3rd Department of Cardiology, National and Kapodistrian University of Athens, Medical School, Clinical Scholar at Harvard Medical School, Associate Editor of European Heart Journal - Case Reports, and an Expert on medical devices at the European Commission.

My work focuses on cardiovascular medicine, cardiac electrophysiology, device therapy, and antiplatelet therapy. I have published in leading journals, including the New England Journal of Medicine, Circulation, Journal of Heart and Lung Transplantation, and Annals of Surgery. My research activity is documented by the production of 106 published articles in high-impact medical journals; all indexed in PubMed.

Among notable honors, I was awarded: Fellow of the European Society of Cardiology (FESC), as a symbol of Scientific Excellence from the European Society of Cardiology in 2017, Fellow of the American College of Cardiology (FACC) Designation from the American College of Cardiology in 2018, Fellow of the European Heart Rhythm Association (FEHRA) honorary recognition from the European Heart Rhythm Association in 2019, Lifetime Member of the European Society of Cardiology Working Group on Cardiac Cellular Electrophysiology, and Lifetime Member of the European Society of Cardiology Working Group on Thrombosis.

I hold an MD from National and Kapodistrian University of Athens, Medical School, a MSc in Thrombosis, Hemorrhage and Transfusion medicine from National and Kapodistrian University of Athens, Medical School, a MHCM from Conservatoire National des Arts et Métiers, and a Master in Interventional Electrophysiology from Università Vita-Salute San Raffaele.
